The name of the Company is Bayard, LLC.

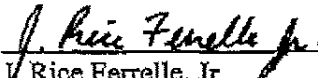
ARTICLE II - PRINCIPAL OFFICE

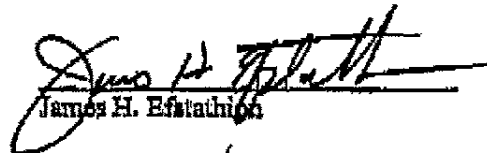
