**ARTICLE IV - REGISTERED OFFICE AND AGENT**

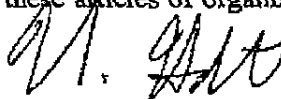

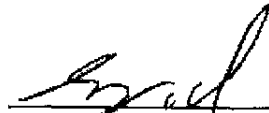
