ARTICLES OF ORGANIZATION OF K C WEBB PROPERTIES, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be K C WEBB PROPERTIES, LLC ("company").

ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the company is 1202 BOWER LANE Lady Lake, Fl 32159.

ARTICLE III -- DURATION
