**ARTICLES OF ORGANIZATION OF
IBUSA, LLC
A FLORIDA LIMITED LIABILITY COMPANY**

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I - Name

The name of the limited liability company (hereinafter referred to as the "Company") is "IBUSA, LLC."

ARTICLE II - Address

The mailing address and street address of the principal office of the Company is 5000 S.E. 39th Court, Ocala, Florida 34480.

ARTICLE III - Duration

The period of duration for the Company shall be perpetual.

The Company is to be managed by the members.


ARTICLE VI - Limitation on Agency Authority of Members
