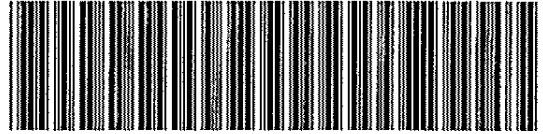



## ARTICLES OF ORGANIZATION

OF

### ALPHA RESTORATION, LLC.

The undersigned subscriber to these Articles of Organization, a corporation organized under the laws of the State of Florida, competent to contract, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act, hereby adopts the following Articles of Organization:

#### ARTICLE I - NAME


