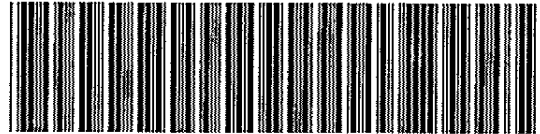



9. The financial and governance rights of the members are subject to restrictions on assignment or transfer in accordance with the terms set forth in the Company's Operating Agreement.


