The name of the Limited Liability Company is LDC MANAGEMENT, LLC.

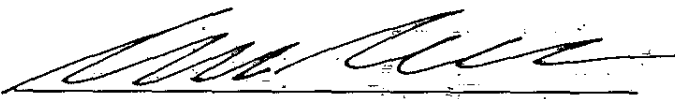
