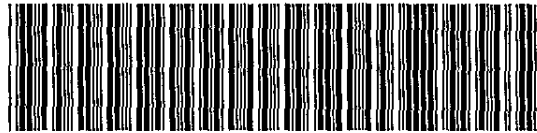



ARTICLE I - Name

The name of the Limited Liability Company is:
