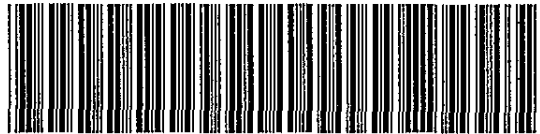



**ARTICLE I - NAME**

**THE NAME OF THIS** Limited Liability Company shall be **MISSION DISTRIBUTING OF TAMPA BAY, L.L.C.,**

**ARTICLE II - ADDRESS**

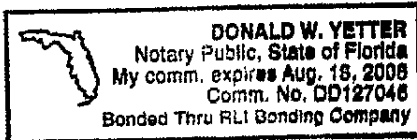


