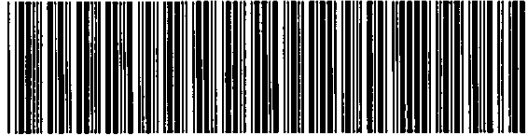



NAME

The name of this limited liability company is Bahama House, LLC.




