The Articles of Organization of the Company were filed on August 23, 2005.

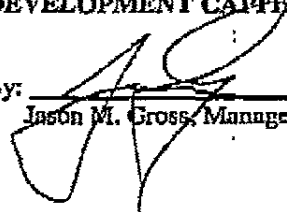
ARTICLE III
