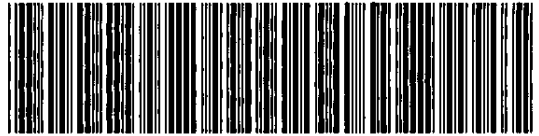

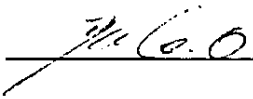

There are no outstanding debts or obligations as Stealth – ISS LLC was never operational.

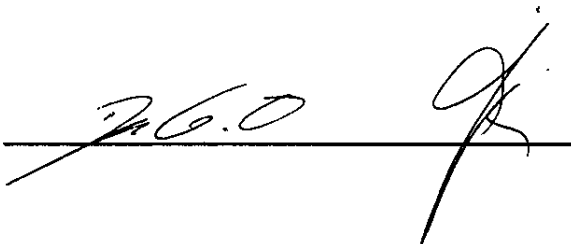
