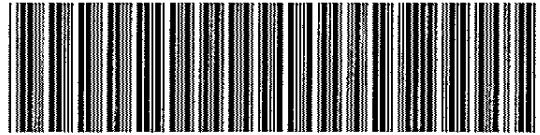

## ARTICLES OF ORGANIZATION

OF

The undersigned authorized representative of the members hereby executes these Articles of Organization ("**Articles**") for the purpose of forming a limited liability company in accordance with the laws of the State of Florida.

### ARTICLE I

#### Name

### Operating Agreement




