**AMENDMENT TO ARTICLES OF ORGANIZATION
OF JOINT DEGREE LAB, LLC, a limited liability company**

THIS AMENDMENT TO ARTICLES OF ORGANIZATION OF JOINT DEGREE LAB, LLC ("Amendment") dated the 3rd day of September, 2005, by JASON NEUFELD and JUSTIN HERTZBERG to amend the Articles of Organization as follows:

WITNESSETH:

1. The name of the Company is hereby amended from "Joint Degree Lab, LLC, a limited liability company" to "Joint Degree Labs, LLC, a Limited Liability company."
 2. The Company shall be a manager managed limited liability company in which the managers of the Company are Jason Neufeld and Justin Hertzberg. The Company may be operated by the managers or the managers shall be entitled to select officers of the Company who shall have similar rights and authority to bind the Company as officers would have the right to bind a corporation governed under Section 607 Florida Statutes.
 3. The Articles of Organization, as modified by this Amendment, remain in full force and effect. To the extent of any inconsistency between the terms of the Articles of Organization and this Amendment, the terms of this Amendment shall supersede and control to the extent of such inconsistency. Terms not otherwise defined herein shall have the meaning set forth in the Articles of Organization.
 4. This Amendment may be executed in one or more counterparts, each of which when taken together shall constitute one and the same amendment. Facsimile transmission signatures of the parties shall be deemed to be original signatures.
