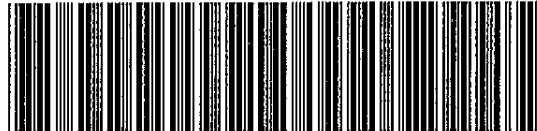

ARTICLES OF ORGANIZATION
OF

The undersigned, acting as the authorized representative of Brenda Dohring Hicks, a member of the Company, and pursuant to section 608.407 of the Florida Limited Liability Company Act, executes the following Articles of Organization:

ARTICLE I. NAME

The name of the limited liability company (the "Company") is:


CERTIFICATE DESIGNATING REGISTERED AGENT
