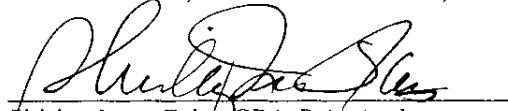
We have been requested to respond to your letter dated April 18, 2007 (copy enclosed) which returned the 2007 Annual Report to the taxpayer for correction.
