

ARTICLES OF ORGANIZATION OF BAP AGENCY, L.L.C.

Story of the story These Articles of Organization are made for the purpose of organizing a Florida Limité Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).
