


MANAGEMENT



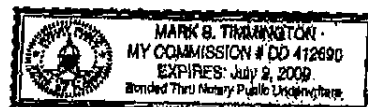
