The undersigned Members hereby file these Articles of Organization in order to form a limited liability company under the laws of the State of Florida.

ARTICLE I. Name

The name of this Limited Liability Company shall be: SDR Construction, L.L.C.

ARTICLE II. Address

The principal place of business of, and the mailing address of, this Limited Liability Company shall be 2434 Oakdale Street, Tallahassee, Florida 32308.
