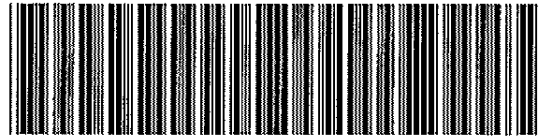

The name of the limited liability company is SA, LLC (the "Company").
