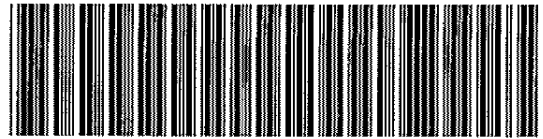


**ARTICLE VI- Admission of Additional Members:**


