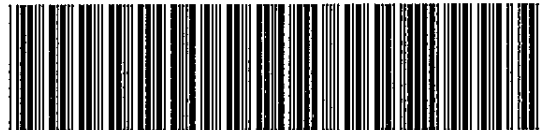

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, does hereby adopt the following Articles of Organization.

Article 1. - Name

The name of the limited liability company is RVS Holdings, L.L.C. (the "Company").

Article 2. - Commencement & Duration

The Company shall commence upon filing of these Articles of Organization with the Florida Department of State and shall continue to exist perpetually.

Article 3. - Company Address

The mailing and street address of the Company's principal office is 4130 Carrollwood Village Dr., Tampa, Florida 33618.

Article 4. - Registered Office & Agent

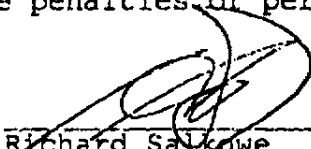

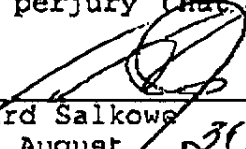
