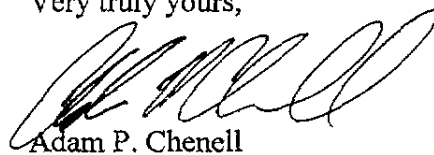

**ARTICLES OF ORGANIZATION**

6. Additional Members. Additional Members to the Company may be admitted, but only upon the unanimous consent of all Members of the Company at the time admission is sought.

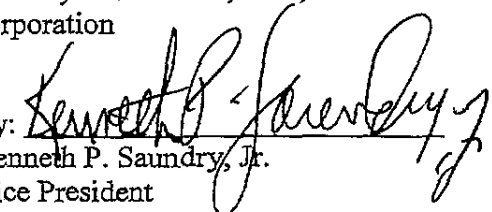

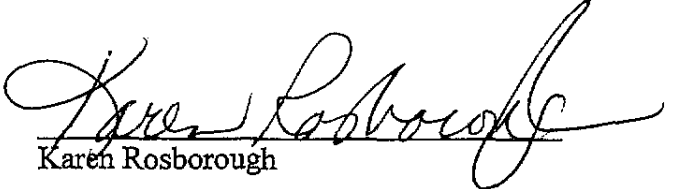
