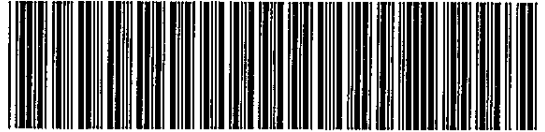

ARTICLES OF ORGANIZATION
FOR IGUANA BE GONNA, LLC,
A FLORIDA LIMITED LIABILITY COMPANY
FILED PURSUANT TO FLORIDA STATUTE §608.407

ARTICLE I

The name of the Company is Iguana Be Gonna, LLC.

ARTICLE II

The mailing address of the principal office of the Company is 29222 Coconut Palm Drive, Big Pine Key, Florida 33403.

ARTICLE III

The Company and the duration of its existence shall commence upon the filing of these Articles and shall continue indefinitely unless sooner terminated in accordance with the provisions of the Operating Agreement.

The member or members shall forthwith execute and record an amendment to the Articles of Organization to evidence such continuation, if required by appropriate governing law.

The net profits and losses of the Company for any year shall be allocated among the members in accordance with the Operating Agreement.


