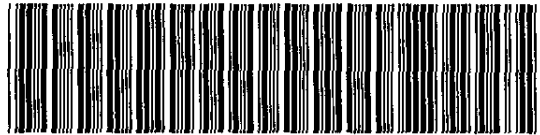




APPOINTMENT OF GENERAL MANAGERS:


