3. **ARTICLE VII** is deleted and the following is substituted in its place:

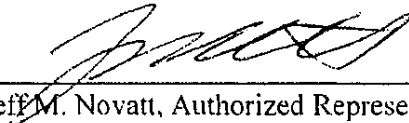
