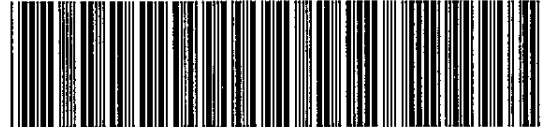


ARTICLE VII ADMISSION OF NEW MEMBERS


