ARTICLES OF ORGANIZATION OF OAK HAMMOCK PLANTATION, LLC.

Article I

OF THE PARTY OF TH The name of the limited liability company ("Company") is OAK HAMM PLANTATION, LLC.

Article II

The mailing address of the Company is 261 E. Davis Street, DeLeon Springs, Florida 32130 and street address of the Company's principal office is the same.
