ARTICLE I



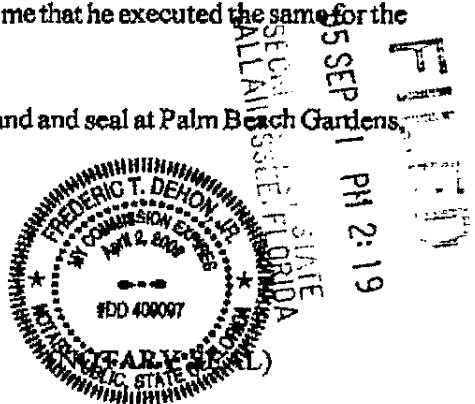


