# ARTICLES OF ORGANIZATION OF MAJESTIC FIVE, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

#### **ARTICLE 1 - NAME**

The company shall be dissolved on the bankruptcy, insanity, resignation, expulsion or dissolution of a member, or on the occurrence of any other event


