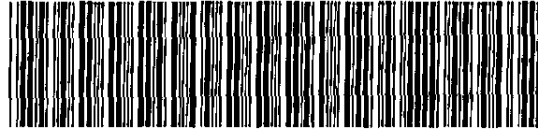

Pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, the undersigned hereby acts as organizer in adopting and filing the following articles of organization for the purpose of organizing a Florida limited liability company.

ARTICLE I
(Name)

The name of the limited liability company is CRD GROUP, LLC (the "Company").

ARTICLE II
(Principal Office)

The mailing address and street address of the initial principal office of the Company is 7568 Fairbanks Ferry Rd., Havana, FL 32333.

ARTICLE III
(Purpose)


