ARTICLES OF ORGANIZATION

OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization:

ARTICLE I

NAME OF THE LIMITED LIABILITY COMPANY

ARTICLE II

ADDRESS

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State or on another effective date if specified. The Company's existence shall be perpetual, unless the Company is dissolved earlier as provided in these Articles of Organization or in the Regulations.

REGISTERED OFFICE AND AGENT

CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the Company only on the unanimous consent of all the members or as provided in the Regulations.

ADMISSION OF NEW MEMBERS

Except as set forth in the Regulations, no additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and on the terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the Company as set forth in

the management of the business and affairs of the Company or become a member-6
unless all of the members of the Company other than the member proposing to

Company is continued by unanimous vote of the remaining members.

ARTICLE IX

MANAGEMENT

The Company shall be managed by the members in accordance with
Regulations adopted by the members for the management of the business and affairs
of the Company. These Regulations may contain any provisions for the regulation and
management of the affairs of the Company not inconsistent with law or these Articles

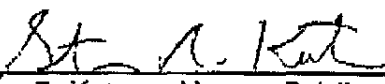
