ARTICLE IV - MANAGEMENT

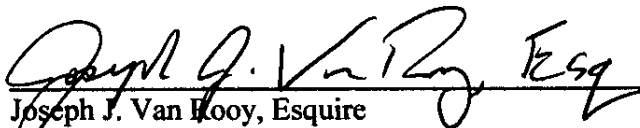
The Company shall be managed by its managing member, Joseph J. Van Rooy, Esquire.

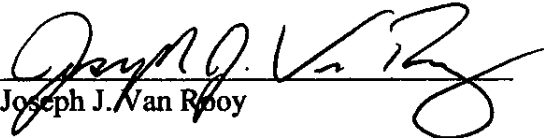
