ARTICLES OF ORGANIZATION OF DONRAY PROPERTIES, LLC

ARTICLE I NAME AND PRINCIPAL PLACE OF BUSINESS

PROPERTIES

The name of this limited liability company shall be DONRAY, LLC, and the mailing address and street address of its principal office shall be 6350 Riverside Drive, Punta Gorda, FL 33980, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.
