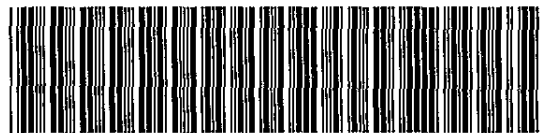

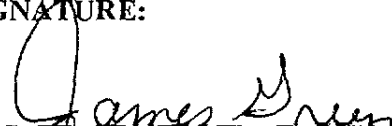

- ARTICLE V: This filing shall become effective on September 1, 2005
- ARTICLE VI: The Limited Liability Company shall be managed by its Members, each of which shall have full and complete authority to make any contracts, enter into any transactions, and make and obtain any commitments on behalf of the Company to conduct or further the Company's business. This provision does not alter or waive any duty that a Member may have to the Company concerning his or her exercise of management authority.
- ARTICLE VII: The Company shall exist for a perpetual duration.
- ARTICLE VIII: If a provision of this Articles of Organization differs from a provision of the Company's Operating Agreement, as the same may be amended from time to time, then, to the extent allowed by law, the Operating Agreement will govern.
- ARTICLE IX: Each Member of the limited liability company shall be indemnified and held harmless by the limited liability company to the fullest extent authorized by the Operating Agreement as adopted by the Members from time to time, or as otherwise may be provided by the Florida Limited Liability Company Act, as currently in effect or as hereafter enacted.
