

ARTICLES OF ORGANIZATION OF WRUK MARCO ISLAND, LLC

- 1. <u>Name.</u> The name of this limited liability company is Wruk Marco Island, LLC, a Florida limited liability company (the "Company").
- 2. <u>Duration</u>. The Company shall have perpetual existence commencing on the filing of the Articles of Organization with the State of Florida and continues even though a membership of a member is terminated.
- 3. <u>Purpose</u>. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida, including purchase, develop, own, sell, manage, lease real estate, including property located at 1395 Leland Way, Marco Island, Florida, Lot 1, Block 792, Marco Beach Unit 25, Collier County, Florida and other property, construct improvements, and such other lawful activities as are reasonably necessary, convenient or incidental to these purposes.
- 4. <u>Place of Business.</u> The mailing and street address of the Company's principal office is 1970 San Marco Road, Marco Island, Florida 34145.
- 5. Registered Agent and Office. The name of the initial registered agent of the Company is Thomas J. Wruk. The street address of the initial registered agent of the Company is 1970 San Marco Road, Marco Island, Florida 34145.
- 6. <u>Additional Members</u>. Additional members to the Company may be admitted, but only upon the unanimous consent of all members of the Company at the time admission is sought.
- 7. <u>Management of the Company</u>. The Company shall be managed by its managers, in accordance with the Regulations adopted by all of the members. The name and address of the managing members are:

- 8. <u>Voting</u>. The Company is authorized to issue membership interests with voting rights amembership interests without voting rights.
- 9. <u>Certificated Interests</u>. The members' interests in the Company may be evidenced by certificates.
- 10. <u>Member's Rights</u>. Pursuant to section 608.4235 of the Florida Statutes, no member of the Company other than the managers shall be an agent of the company solely by virtue of being a

member, and no member other than the managers shall have authority to incur debt or contractual liability on behalf of the company solely by virtue of being a member. Any Operating Agreement of the company as defined in section 608.402(24) of the Florida Statutes must be in writing and signed by all the initial members.

The undersigned managing members freely executed these Articles of Organization effective as of the 31st day of August, 2005, affirming under penalties of perjury that the facts herein are true.
