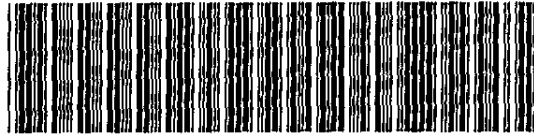

**ARTICLES OF ORGANIZATION
OF
WRUK MARCO ISLAND, LLC**

1. Name. The name of this limited liability company is Wruk Marco Island, LLC, a Florida limited liability company (the "Company").

2. Duration. The Company shall have perpetual existence commencing on the filing of the Articles of Organization with the State of Florida and continues even though a membership of a member is terminated.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida, including purchase, develop, own, sell, manage, lease real estate, including property located at 1395 Leland Way, Marco Island, Florida, Lot 1, Block 792, Marco Beach Unit 25, Collier County, Florida and other property, construct improvements, and such other lawful activities as are reasonably necessary, convenient or incidental to these purposes.

6. Additional Members. Additional members to the Company may be admitted, but only upon the unanimous consent of all members of the Company at the time admission is sought.

Any Operating Agreement of the company as defined in section 608.402(24) of the Florida Statutes must be in writing and signed by all the initial members.
