The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I
NAME AND ADDRESS**

The name of the limited liability company shall be MLC-1 SOLANO, LLC ("Company"). The principal place of business of the Company in Florida shall be 158 Barberry Lane, Ponte Vedra Beach, Florida 32082. The mailing address of the Company shall be 158 Barberry Lane, Ponte Vedra Beach, Florida 32082.

**ARTICLE II
DURATION**

The Company shall commence its existence on the date these Articles of Organization are filed with the Florida Department of State. The Company's existence shall be perpetual, unless the Company is earlier dissolved as provided in these Articles of Organization.

The general purpose for which the Company is organized is to acquire, own, develop, lease, improve, sell and manage real property and to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. Members shall have the right to admit new members only by consent of the majority in interest of the membership. Contributions of new members shall be determined as of the time of admission to the Company.

A member's interest in the Company may not be sold or otherwise transferred, except as provided in the written Operating Agreement of the Company.




