ARTICLES OF ORGANIZATION OF CORAL CLUB INVESTORS, LLC

The undersigned, for the purpose of forming a limited liability company under the Floridac Limited Liability Company Act, pursuant to Chapter 608 of the Florida Statutes, hereby angkes acknowledges and files the following Articles of Organization (the "Articles").

ARTICLE L NAME
