ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF WESTFORK MANAGEMENT LLC

- 1. The name of the limited liability company is Westfork Management LLC (the "Company").
- 2. The date of filing of the Articles of Organization of the Company with the Secretary of State of the State of Florida was September 8, 2005, under Document Number L05000088901 (the "Original Articles"). - 1. <u>Purpose</u>. The purpose of the Company shall be to engage solely in the following activities:
- (a) To acquire membership interests in Westfork Plaza LLC, Westfork Investors LLC, Paraiso Operating LLC and Paraiso Investors LLC.
- (b) To exercise all powers enumerated in the Florida Limited Liability Company Act necessary or convenient to the conduct, promotion or attainment of the business or purposes otherwise set forth herein or the Company's Operating Agreement (subject to these Articles)."
- 4. All other provisions of the Articles shall remain in full force and effect without any modification thereof.
