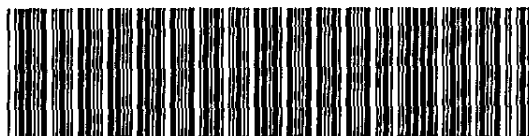

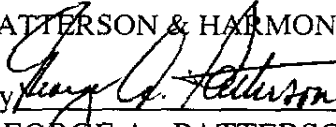

ARTICLES OF ORGANIZATION
OF
BLPLRP, LLC

ARTICLE I — Name:

The name of the Limited Liability Company (hereinafter referred to as the "Company") is BLPLRP, LLC

ARTICLE II — Duration:

The Company's period of duration shall be perpetual.

ARTICLE III — Address:

The mailing address and street address of the principal office of the Company shall be 1528 S.E. 12th Court, Deerfield Beach, Florida 33441.

ARTICLE IV — Registered Agent and Address:

The name of the Company's initial registered agent is George A. Patterson, and the street address of said registered agent is 1528 S.E. 12th Court, Deerfield Beach, Florida 33441.

ARTICLE V — Additional Members:

The right, if given, of the Members of the Company to admit additional members and the terms and conditions of the admission of such additional members shall be pursuant to the Operating Agreement for the Company, executed by the Members, then in effect.

**ARTICLE VI — Death, Resignation, Expulsion, Bankruptcy, or
Dissolution of a Member:**

The right, if given, of the remaining Members of the Company to continue the business of the Company in the event of the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company shall be pursuant to the Operating Agreement for the Company, executed by the Members, then in effect.

ARTICLE VII — Purpose:

The purpose for which the Company is organized is to transact all lawful business for which companies may be organized under the Florida Limited Liability Company Act.

ARTICLE VIII — Management:

The Limited Liability Company shall be managed by one or more Members whose identities and terms of office shall be set forth in the written Operating Agreement of the Limited Liability Company.

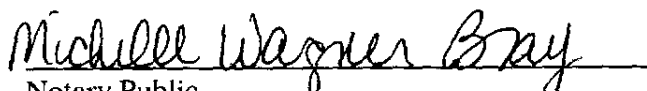

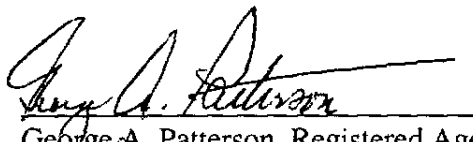
