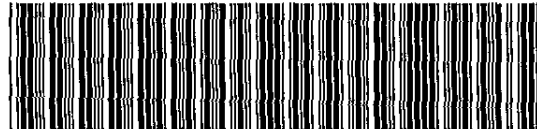

The Company is to be managed by the Member and the name and address of the initial Manager is:

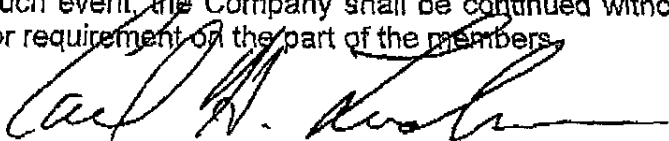
