ARTICLES OF ORGANIZATION

OF

These Articles of Organization of Pine Valley #2963, L.L.C., are being duly executed and filed to form a limited liability company pursuant to the Florida Limited Liability Company Act (the Act).

ARTICLE I

Name

The name of the limited liability company (the Company) formed hereby is:

ARTICLE II

Address of Principal Office
