ARTICLES OF ORGANIZATION FOR BRANCH, LLC, A FLORIDA LIMITED LIABILITY COMPANY FILED PURSUANT TO FLORIDA STATUTE §608.407

ARTICLE I

The name of the Company is Branch, LLC.

ARTICLE II

The mailing and street address of the principal office of the Company is Post Office Box 220, Pahokee, Florida 33476.

ARTICLE III

The Company and the duration of its existence shall commence upon the filing of these Articles and shall continue indefinitely unless sooner terminated in accordance with the provisions of the Operating Agreement.
