ARTICLES OF ORGANIZATION

OF

M & S INVESTMENT PROPERTIES, LLC

The undersigned, an authorized natural person, for the purpose of forming a limited liability company under the provisions and subject to the requirements of Chapter 608 of the Florida Statutes (including all amendments and/or supplements thereto and collectively known and identified as the "Florida Limited Liability Company Att" and hereinafter referred to as the "Act") hereby certifies that:

ARTICLE I - NAME

The name of the limited liability company shall be "M & S Investment Properties, LLC" (hereinafter referred to as the "Company").

ARTICLE II - ADDRESS

ARTICLE III - REGISTERED OFFICE AND AGENT

ARTICLE V-DURATION

The Company shall commence its existence upon the filing of these Articles of Organization (hereinafter referred to as the "Articles") with the Secretary of State of the State of Florida and will continue in existence thereafter until December 31, 2050, unless sooner terminated pursuant to any provisions of the Company's Operating Agreement or the Act.

ARTICLE VI - PURPOSES AND POWERS

The purposes of the Company will be to engage in any lawful act or activity for which limited liability companies may be formed under the Act. In furtherance of the purposes of the Company, the Company shall have the power to do any and all other things necessary or desirable to implement the foregoing and as otherwise provided in or contemplated by these Articles and in connection therewith the Company shall have, and may exercise, any and all powers conferred upon limited liability companies pursuant to the Act.

ARTICLE VII-LIABILITY

None of the Members, the Managers nor the Board of Managers (as such terms are defined in the Company's Operating Agreement) shall be liable under a judgment, decree or order of a court, or in any other manner, for a debt, obligation or liability of the Company except as expressly provided in the Company's Operating Agreement.

ARTICLE VIII - OPERATING AGREEMENT

Except as otherwise expressly provided in these Articles, the respective rights, duties, benefits and obligations of the Members shall be as set forth in the Operating Agreement adopted by the Members. Each Member shall upon admission to the Company, subscribe such Operating Agreement, as from time to time amended, and any person and/or entity acquiring Units (as defined in the Operating Agreement and howsoever acquired) shall be and be deemed, upon such acquisition, to have agreed to be bound by the terms and conditions of these Articles and the Operating Agreement.

ARTICLE IX - AMENDMENT

Subject to the provisions of the Operating Agreement, the Company reserves the right to amend, modify or repeal any of the provisions contained herein or in the Operating Agreement in the manner herein and therein respectively provided; and any right conferred upon the Members is subject to such reservation.
