In addition to the indemnification conferred in this Article, the Indemnitee shall also be entitled to have paid directly by the Company the expenses reasonably incurred in defending any such proceeding against such indemnitee in advance of its final disposition, to the fullest extent authorized by applicable law, as the same exists or may be earlier be amended. The rights and authority conferred in this Article shall not be exclusive of any other right which any person may have or hereafter acquire under my statute, provision of the Articles of Organization or Operating Agreement of the Company, agreement, vote of Members or otherwise. Any rapeal or amendment of this Article by the Members of the Company shall not adversely affect any right or protection of a manager or officer existing at the time of such repeal or amendment.
