**ARTICLES OF ORGANIZATION
OF

The undersigned subscriber to these Articles of Organization, a natural person competent to contract, does hereby form a limited liability company under the laws of the State of Florida.

ARTICLE I

Name

The name of the limited liability company shall be Fiberglass Pultrusion, LLC.

ARTICLE II

Address and Place of Business

ARTICLE VI
Management

The management of the limited liability company, unless otherwise provided in the articles of organization or the operating agreement, shall be vested in a Board of Managers.

ARTICLE VII
Continuity of Business

Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or upon the occurrence of any other event which terminates the continued membership of a member in the limited liability company, the limited liability company shall not be dissolved unless the business of the limited liability company is terminated by the consent or agreement of all members.

Operating Agreement

The members of the limited liability company shall adopt an operating agreement which shall act as the operating agreement of the members pertaining to the regulation and management of the limited liability company, provided that such operating agreement shall not be inconsistent with the Articles of Organization or with the laws of the State of Florida. The operating agreement shall be subject to the laws of the State of Florida.

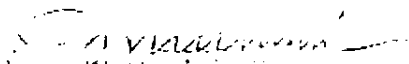
