ARTICLES OF ORGANIZATION OF LVM CONSTRUCTION, LLC.

The undersigned certify that we have associated for the purpose of becoming a limited liability company under the Laws of the State of Florida, Florida Statute 608-Florida Limited Liability Company Act, providing for the information, rights, privileges, and immunities of limited liability companies for profit. We further declare that the following Articles shall serve as the Charter and authority for the conduct of business of the limited liability company.

ARTICLE I NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the limited liability company shall be LVM CONSTRUCTION, LLC and its principal office address shall be located at 1290 WESTON ROAD, SUITE 306 17, WESTON, FL 33326, and its mailing address shall be the same, but it shall have the power and authority to establish branch offices at any other places as the members may designate.

ARTICLE II PURPOSES AND POWERS

To enter into and make all necessary contracts for its business with any person, entity, partnership, association, corporation, domestic or foreign, or of any domestic or foreign state, government, or government authority, or of any political or administrative subdivision, or department, and to perform and carry out, assign, cancel or rescind any of such contracts.
