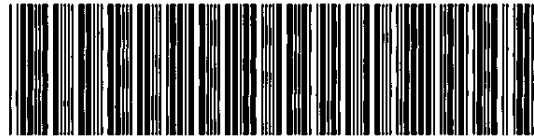

2. The remainder of the Articles of Organization shall remain the same, except as herein amended, and shall remain in full force and effect.

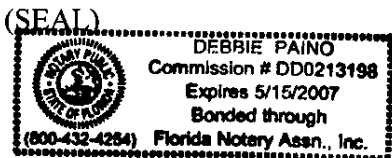
