ARTICLE VII - MANAGEMENT

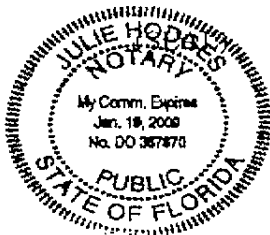

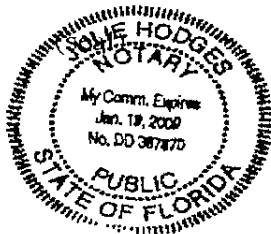
